As a result of legislation enacted into law this year the State of New Jersey will be offering in-person early voting on a machine during a nine day period. In addition to providing early voting, registered voters will continue to have the option of voting by mail or in-person at their polling place on Election Day. Below is a sample copy of the ballot that will appear on the new voting machines at the 10 early voting sites throughout Ocean County. New electronic poll books will be used to sign-in voters. Poll workers will be available to assist all voters in using these new devices. The early voting locations are listed below. Hours for early voting are Monday-Saturday, 10am to 8pm and Sunday 10am to 6pm. It doesn't matter where you live in Ocean County registered voters can go to any of the 10 sites and conveniently cast your ballot on a voting machine.

STATE QUESTION NO. 1 CONSTITUTIONAL AMENDMENT TO PERMIT WAGERING ON ALL COLLEGE SPORT OR ATHLETIC EVENTS

Do you approve amending the Constitution to permit all groups that are allowed to conduct bingo or raffles to use the net proceeds from those games to support their groups?

Currently, only veterans and senior citizen groups may use the net proceeds from those games to support their groups. All other groups that are permitted to conduct bingo or raffles may only use the proceeds from those games for certain purposes. They are not permitted to use those proceeds to support their groups. INTERPRETIVE STATEMENT

The net proceeds from those games of chance may only be used for educational, charitable, patriotic, religious or public-spirited uses. However, veterans and senior citizen groups may also use the proceeds from those games to support their groups.

This amendment would permit all of the groups authorized to conduct games of chance to use the net proceeds from conducting bingo or raffles to support their groups.
