

Print, Website or TV Advertising must feature the complete logo as provided. Logo must be READABLE and no smaller than minimum size requirement indicated. Radio Advertising will only be approved if voiceover contains "Funded in Part by a Grant from the Ocean County Board of Chosen Freeholders" and "Visit their Website at www.oceancountytourism.com."

Proof must be submitted digitally through email, DVD or CD. In the event that an ad is too small to include the full tourism seal plus verbiage, the tourism seal may be omitted but all of the verbiage, including the WEBSITE must be included for the ad to comply.

** The examples below represent the MINIMUM size requirement. Verbiage and website must be legible in the ad. If you are unsure, please provide the proof of the ad for our approval.**
