PUBLIC QUESTION TO BE VOTED UPON

PROPOSAL

The Board of Education of the Borough of Island Heights in the County of Ocean, New Jersey is authorized: (a) to undertake various improvements and renovations to the Island Heights Elementary School, including the acquisition and installation of equipment and any necessary site work; (b) to appropriate \$4,030,065 for such purposes; and (c) to issue bonds of the School District in the principal amount of \$4,030,065.

The final eligible costs of the projects approved by the Commissioner of Education are \$4,030,065. The proposed improvements do not include school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due on the final eligible costs of the projects.
