Yesterday's Operations:

• Sediment removal continued in River Barge Marina and Dragonfly Marina in the Hackensack River. Debris and Target Removal occurred in the areas Liberty Landing Marina. Completed marsh cleanup in the areas of Matawan Creek.

Forecasted Operations:

• Friday: In Zone 1, sediment removal will continue within the Hackensack Marina. Target and debris removal in the Hudson River. In Zone 2, target and debris removal is occurring in Raritan Bay, Matawan Creek and Cheesequake Creek.

• Four day outlook: In Zone 1, sediment removal will continue in the Hackensack and Hudson River Marinas. In Zone 2, target and debris removal will continue in Raritan Bay, Matawan Creek, Cheesequake Creek. Sediment removal in Shrewsburg Bay.

Yesterday's Operations:

• Debris and target removal crews worked at Gunning Island, in the Fairhaven and Rumson areas on the Navasink River, in the Manasquan River near the north end of Brick and Point Pleasant, and the Bayville and Drum Point area. Debris removal operations focused on removing visible and floating debris, as well as searching for submerged debris and targets in Zones 3, 4, and 7. Side scan sonar operations began from the Manasquan inlet to the Shark inlet on the ocean side.

Forecasted Operations:

- Friday: Sediment removal operations continue in zone 4, area 6. Initial sediment screening operations to begin. Target and debris removal on Gunning Island, the Navasink River, Manasquan river, and the Drum Point area and Bayville area
- Five day outlook: Target and debris recovery will continue in Zone 3 near Navesink at Black Point Creek, Oceanic Bridge, Upper Navesink River, Monmouth Beach Channel, and Rumson County Club Channel. Sediment removal to continue in zone 4. Operations on the Shark River within the week.

Yesterday's Operations:

- Hand removal of debris to the surge line in Steelman Bay (Zone 10); and Patcong Creek, and Cowpen Island behind Ocean City (Zone 11).
- Target and debris removal was performed in marshland, Schimpfs and Sheltered Cove Marina, as well as DOT Channels #160, #161 and #162 (Zone 9); Cedar Creek in the Cedarville area and Maurice River surge line in Heislerville (Zone11).
- Side scan sonar was conducted in Crab Island (Zone 9).
- Replanted previously damaged area in Bowers Creek Rd. (Zone 11).

Forecasted Operations:

• Friday: Hand debris removal in and around Brigantine Island, (Zone 10); and Patcong Creek (Zone 11).



- Target and debris removal at DOT Channel #157 (Zone 9); Tuckahoe River DOT Channel, storm surge line in Patcong Creek, also behind Ocean City area in the ICW & surrounding islands, Cedar Creek at Cedarville and Maurice River in Heislerville (Zone 11).
- Four day outlook: Target and debris removal to continue in Cape May County, Cedar Creek, Heislerville, and Back Creek moving towards Bay Point, (Zone 11). Side scan sonar continuing in Zones 8, 9, 10 and 11.
