## This Week's Operations:

• Debris removal crews worked in the Rumson and Toms River areas in Zones 3 & 5 removing debris. Sediment removal and sand screening operations continued in Zone 4 areas 3 and 4, and Zone 5 area 5.

## Next Week's Operations:

• Debris operations have achieved substantial completion and contractor will continue to respond to new debris sighting reports. Sediment removal and sand screening operations to continue in Zone 4 areas 3 and 4, and Zone 5 area 5. Beach quality sand is being relocated for beach renourishment operations at beaches near Downer and Lyman Street. Sediment removal operations in Zone 4 area 5b and Zone 5 area 7 to begin within the week.
