In addition to providing early voting, registered voters will continue to have the option of voting by mail or in-person at their polling place on Election Day. Below is a sample copy of the ballot that will appear on the new voting machines at the 10 early voting sites throughout Ocean County. New electronic poll books will be used to sign-in voters. Poll workers will be available to assist all voters in using these new devices. The early voting locations are listed below. Hours for early voting are Monday-Saturday, 10am to 8pm and Sunday 10am to 6pm. It doesn't matter where you live in Ocean County - registered voters can go to any of the 10 sites and conveniently cast your ballot on a voting machine.
