- 1. All recording fees include the \$5 homelessness trust fund fee**
- 2. All recording fees include the first marginal notation when applicable**
- 3. A \$20 additional fee will apply to all documents being recorded without a document recording coversheet**
- 4. Documents that have more than 5 names between the parties are subject to an indexing fee of \$6 per name after the first 5**
- 5. Re-recorded documents and corrective documents are subject to an additional \$10.00 re-recording fee**
- 6. Documents being recorded by a municipality or township are a flat fee of \$13**
- 7. All checks received by the recording office over \$10,000 need to be certified. This includes all checks made payable to the State of NJ Division of Taxation**
- 8. Cash, check and escrow accounts are the only forms of payment we accept to record documents.**
