NORTHERN REGION:

To Date:

- Total cubic yards of debris removed (inland): 7,106
- Total number of large debris recovered: 38 vessels
- Total verified sediment removal (total cubic yards): 81,983
- Total verified acres surveyed by side scan sonar: 32,438 (adjusted)
- Estimated hydrographic survey acres: 177
- Total targets identified: 1,896
- Total targets retrieved: 767
- Total targets disqualified/below draft depth: 1,059

Yesterday's Operations:

• In Zone 1, debris removal took place in the vicinity of Elizabeth River and sediment removal occurred in Smiths Creek. In Zone 2, sediment removal took place in Captain's Cove Marina and in Gateway Marina.

Forecasted Operations:

• Friday: Sediment removal will continue in the DOT Channel of Smiths Creek and Gateway Marina. Debris removal will take place in the Elizabeth area. Additionally, a hydrographic survey will be conducted in the Hackensack Marina.

• Four-day outlook: Sediment removal will continue in marinas within Zones 1 and 2, and Smiths Creek. The contractor will continue to respond to new debris sighting reports.

Yesterday's Operations:

• Debris removal crews worked in the Lavallette area and Island Beach State Park removing debris. Sediment removal and sand screening operations continued in Zone 4.

Forecasted Operations:

- Friday: Debris removal crews are working in the Metedeconk River, Lavallette area and Island Beach State Park in Zones 4 and 7 removing debris. Sediment removal and sand screening operations to continue in Zone 4.
- Five-day outlook: Debris operations have achieved substantial completion and contractor will continue to respond to new debris sighting reports. Sediment removal and sand screening operations to continue in Zone 4. Beach quality sand will continue to be relocated to Brick Beach.
