As we look forward to 2016, I want to take this opportunity to tell you I have contacted our legislative leaders to express my disappointment in the fact that there is no Social Security COLA increase planned in 2016; as in the past, I will continue to advocate for both Medicare and Social Security issues throughout the year.

Let me also extend a special thank you to all of those who have Freeholder Joseph H. Vicari helped us to carry out the work of Senior Services throughout the year. Ocean County has a wonderful system of services for older adults and their caregivers but it would not be possible without the effort of our staff, service providers, advisory council, governmental officials and volunteers working together in that common goal.

We ended the year with an enormously successful Medicare Part D Enrollment; more than one client has saved thousands of dollars by working with our State Health Insurance Program (SHIP) counselors to find the right plan to assist them with pharmaceutical costs in the New Year. These counselors continue to lead the state in their client activity.

Access to services is provided through the five Information and Assistance Representatives located at the main Office of Senior Šervices at 1027 Hooper Ave., Building #2, Toms River and the two additional representatives stationed for your convenience at the County Connection at the Ocean County Mall.

Our staff assists callers/walk-ins with community resource information as well as applications for numerous benefits. The priority issue areas for 2015 were identified as follows: Medicare/Health Insurance, Prescriptions, In Home Services, Caregiver Information, Housing, Nutrition, Utility Assistance and Tax Programs. *Continued on next page*

Additionally, those same services are provided at various funded Outreach locations throughout Ocean County. The Office of Senior Services has toll-free telephone numbers and a website at www.co.ocean.nj.us. The Ocean County Office of Senior Services resource directory is also available online. Not only can the resource directory be viewed on the Internet; specific documents can be e-mailed to older adults and caregivers. As we came to print there were over 18,000 website hits in the last year alone. This is an especially helpful tool for working caregivers or long distance caregivers.

Our department administers a comprehensive system of community based services including Access Services such as transportation, information and assistance and care management; Community Support such as education, recreation, physical and mental health screenings, physical fitness, adult day services, legal assistance; Home Support such as friendly visitor, telephone reassurance, residential maintenance, housekeeping, certified home health aide; Nutrition Support such as congregate meals, home delivered meals, nutrition counseling and education, Caregiver Support such as Respite, Caregiver Support Groups, In-Home Education and Support, etc.


It is important to note that the Office of Senior Services has once again received high marks in a recent on-site assessment conducted by the State of New Jersey. The annual assessment by the Division of Aging
