Do you know of a homeowner whose home was damaged or destroyed by Super Storm Sandy and who cannot afford the costs of repair or reconstruction? Is there someone in your community whose home has fallen into disrepair and who needs help?

If you do, please help the homeowner complete the attached application and return it to Coastal Habitat for Humanity for assistance. Applications received by February 15, 2013 will be given first priority.

Coastal Habitat's Neighborhood Revitalization Initiative (NRI) is a hand up, not a hand out.

- Super-Storm Sandy devastated the Jersey Shore. While the storm didn't create the affordable housing crisis in our community, it definitely exacerbated it. As in most disasters, the people hurt the most are those who had the least to begin with.
- During this time of responding to the needs of those affected by the storm, Coastal Habitat for Humanity will also continue the important work of rebuilding, restoring, and repairing homes for homeowners in difficult economic circumstances. Many of these community residents are elderly or disabled and can no longer manage the upkeep of their houses by themselves.
- Assistance from Coastal Habitat's NRI is the hand up many need to continue to live safely in their homes. At the same time, improving homes in disrepair builds community and contributes to the value of the surrounding neighborhoods.
- If physically able, homeowners and members of their household commit to working alongside the volunteers. Homeowners also commit to a financial contribution for the cost of the materials used. A time payment plan is set up based on the homeowner's income.
- Coastal Habitat for Humanity helps people whose annual income falls within the following guidelines:

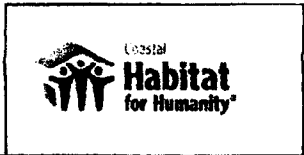

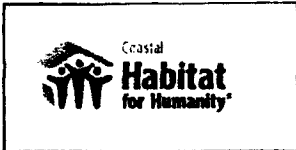


