



Freeholder Director Joseph H. Vicari opened the meeting at 4:00 PM and read the Statement of Compliance with the Open Public Meetings Act. The Clerk of the Board called the roll.

Freeholder Bartlett reviewed with the Board twoparcels recommended for acquisition through the Natural Lands Trust Fund (NLTF). The Freeholder noted that the first parcel recommended is an in-holding that is privately owned in the larger 126 acre Lifetime Homes parcel which was one of the first purchases by the County through the NLTF. This in-holding is approximately a tenth of an acre and is a donation to the County. It is the last outlying parcel in this area.

Members of the Board of Chosen Freeholders December 11, 2014 Summary of the Pre-Board meeting of December 10, 2014 Page 2

Freeholder Bartlett stated that the second parcel for acquisition is located in Plumsted Township and is 10 acres known as the Stults Estate. The Freeholder noted that the estate is happy to sell the parcel to the County for \$94,000. Freeholder Bartlett advised that this acquisition will close a gap in the Township's project area to preserve a contiguous tract of sensitive land. The Freeholder stated that the Township will manage the property.

Freeholder Bartlett stated that all of the parcels acquired by the NLTF are from willing sellers, done with appraisals, and the County never pays more than the appraised value. These parcels will be listed for the Board meeting of December 17, 2014 for acquisition.

Freeholder Lacey advised that while the County is the clearing house for recycled materials, the agreements need to be renewed with municipalities. Ernest Kuhlwein, Director of Solid Waste Management, was in attendance and stated that the County is reaching the end of the five year period of the agreements with municipalities. Freeholder Lacey noted that this program began in 1995, and since that time \$14.9 million has been distributed to municipalities and over 1.3 tons of material has been recycled. The Freeholder stated that almost \$100 million in tipping fees have been saved by the municipalities.

Mr. Kuhlwein stated that the single stream system is very successful and has increased the amount of recyclables coming in to the recycling centers. Mr. Kuhlwein advised that people are encouraged, however, not to put plastic bags in with their recycling, it damages the machines. Freeholder Bartlett stated that for those that live in small homes or condominiums, single stream recycling works very well, you do not have room to source separate materials in a condominium.

Freeholder Lacey stated that recycling is important and education is key to recycling, some things can not be recycled. Recycling is saving our resources by reusing materials.

Mr. Scarantino reviewed the items listed on the attached Engineering Department agenda. Mr. Scarantino stated that there are no new projects for today's agenda. There were no questions or comments, and all items will be listed on the agenda for the December 17, 2014 Board meeting.

Ms. Vasil reviewed the Clerk of the Board's agenda for the Board meeting of December 17, 2014. Ms. Vasil advised that a bid for audio visual will be added to the Board agenda. There were no questions or comments.

Director Vicari stated that the last Board meeting of the year will be held on December 17, 2014.

Director Vicari asked the Board members for comments.

Freeholder Little thanked the Director for a good year.

There were no additional comments.

Ms. Vasil read the resolution to move to closed session.

On a motion by Freeholder Lacey, seconded by Freeholder Bartlett, the meeting moved to Closed Session at 4:20 PM for personnel discussion, appointments, reappointments, property acquisition and possible litigation. The motion was unanimously carried.






