PUBLIC QUESTION TO BE VOTED UPON

PROPOSAL

The Board of Education of the Toms River Regional School District in the County of Ocean, New Jersey is authorized: (a) to undertake various renovations, alterations, and improvements at Beachwood Elementary School, Cedar Grove Elementary School, Joseph A. Citta Elementary School, East Dover Elementary School, Hooper Avenue Elementary School, North Dover Elementary School, Pine Beach Elementary School, Silver Bay Elementary School, South Toms River Elementary School, Walnut Street Elementary School, Washington Street Elementary School, West Dover Elementary School, Intermediate East School, Intermediate North School, Intermediate South School, High School East, High School North, High School South, Administration Building, John Bennett Athletic Center, Vehicle Maintenance Compound, District Maintenance Compound and Central Registration Complex and including related technology, fixtures, furnishings, equipment, site work and related work; (b) to appropriate \$147,148,269 for such purposes; and (c) to issue bonds of the school district in the principal amount of \$147,148,269.

The final eligible costs of the projects approved by the Commissioner of Education are \$139,063,509 (with \$2,165,100 allocated to Beachwood Elementary School, \$4,096,045 allocated to Cedar Grove Elementary School, \$2,349,450 allocated to Joseph A. Citta Elementary School, \$3,675,625 allocated to East Dover Elementary School, \$4,649,950 allocated to Hooper Avenue Elementary School, \$4,298,373 allocated to North Dover Elementary School, \$4,521,000 allocated to Pine Beach Elementary School, \$6,658,275 allocated to Silver Bay Elementary School, \$3,451,225 allocated to South Toms River Elementary School, \$5,012,370 allocated to Walnut Street Elementary School, \$3,852,260 allocated to Washington Street Elementary School, \$3,572,040 allocated to West Dover Elementary School, \$13,451,900 allocated to Intermediate East School, \$11,376,200 allocated to Intermediate North School, \$6,367,650 allocated to Intermediate South School, \$14,206,663 allocated to High School East, \$32,385,080 allocated to High School North, \$12,974,303 allocated to High School South, \$0 allocated to the Administration Building, \$0 allocated to the John Bennett Athletic Center, \$0 allocated to the Vehicle Maintenance Compound, \$0 allocated to the District Maintenance Compound and \$0 allocated to the Central Registration Complex). The proposed improvements include \$8,084,760 (with \$476,000 allocated to High School East, \$350,000 allocated to High School North, \$700,000 allocated to High School South, \$1,281,850 allocated to the Administration Building, \$2,282,770 allocated to the John Bennett Athletic Center, \$876,500 allocated to the Vehicle Maintenance Compound, \$1,736,760 allocated to the District Maintenance Compound and \$380,880 allocated to the Central Registration Complex) for school construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this special election.
