## Subsidized & Low Income Housing

Subsidized housing refers to apartments or attached housing where the amount of rent is based on the income of the household. The state or federal government usually finances construction or rental costs, and the units are sponsored by non-profit or limited-profit organizations or public housing authorities. Low Income Housing is a special housing category that affords investors special tax treatment in return for a discounted rental rate for eligible applicants. The Low Income Housing Tax Credit is a program of the Internal Revenue Service, where landlords obtain tax benefits for renting to low income households.
