ORDINANCE #2020-20

AN ORDINANCE AUTHORIZING THE DEVELOPMENT AND CONSTRUCTION OF THE SOCIAL SERVICES COMPLEX, LOCATED IN TOMS RIVER TOWNSHIP, COUNTY OF OCEAN, STATE OF NEW JERSEY, AND APPROPRIATING \$56,800,000 THEREFOR, AND AUTHORIZING THE ISSUANCE OF \$53,700,000 IN BONDS OR BOND ANTICIPATION NOTES OF THE COUNTY OF OCEAN TO FINANCE THE SAME.

BE IT ORDAINED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF OCEAN, IN THE STATE OF NEW JERSEY (NOT LESS THAN TWO THIRDS OF ALL MEMBERS THEREOF AFFIRMATIVELY CONCURRING) AS FOLLOWS:

SECTION 1. The following is hereby authorized to be undertaken by the County of Ocean as general improvements, a project consisting of the development and construction of the Social Services Complex, including but not limited to acquisition of related furnishings and equipment, located in Toms River Township, in the County of Ocean, State of New Jersey, including all else necessary therefor or incidental

thereto.

SECTION 2. It is hereby found, determined and declared that the improvements or purposes, the

estimated cost of the improvements and appropriation therefor, down payment and estimated maximum amount of bonds or notes authorized are as follows:

Development and construction of the Social Services Complex, located in Toms River Township

SECTION 3. There is hereby appropriated the sum of \$56,800,000, including the sum of \$3,100,000 as the down payment, for the improvements or purposes described in Section 1 hereof as required by the Local Bond Law. The down payment has been made available by virtue of provision in the Capital Improvement Fund of the County of Ocean in one or more previously adopted budgets.

SECTION 4. There is hereby authorized the issuance of negotiable bonds in an aggregate principal amount of \$53,700,000 to finance part of the cost of the purposes stated in Section 1 hereof. Said bonds shall bear interest at a rate not exceeding the limit authorized by law, and the maturities, method of sale and other details thereof shall be determined by subsequent resolutions to be adopted in the manner provided by law.

SECTION 5. In order to temporarily finance the purposes provided for in Section 1 hereof, there is hereby authorized the issuance of bond anticipation notes of said County in an aggregate principal amount of \$53,700,000. All bond anticipation notes issued hereunder shall mature at such times as may be determined

by the County Comptroller; provided that no note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and shall be in such form as may be determined by the County Comptroller. The County Comptroller shall determine all matters in connection with notes issued pursuant to this Ordinance, and the County Comptroller's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8.1. The County Comptroller is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The County Comptroller is directed to report in writing to the Board of Chosen Freeholders at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this Ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

SECTION 6. The County reasonably expects to commence acquisition and/or construction of the improvements described in Section 1 hereof, and to advance all or a portion of the costs in respect thereof, prior to the issuance of bonds or notes hereunder. To the extent such costs are advanced, the County further reasonably expects to reimburse such expenditures from the proceeds of the bonds or notes authorized by this bond ordinance, in an aggregate amount not to exceed the amount of bonds or notes authorized in Section 2 hereof. This bond ordinance is intended to be a declaration of official intent under Treasury Regulation Section 1.150-2.

SECTION 7. Any grant monies received for the purposes described in Section 1 hereof, shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

SECTION 8. The amount of the proceeds of the obligations authorized by this Ordinance which may be used for the payment of interest on such obligations, architects' fees, accounting, engineering and inspection costs, legal expenses, and other items as provided in N.J.S.A. 40A:2-20 shall not exceed the sum of \$6,000,000.

SECTION 9. The Capital Budget of the County of Ocean is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services is on file with the Clerk of the Board of Chosen Frecholders and is available there for public inspection.

SECTION 10. It is hereby found, determined and declared as follows:

A. The improvements or purposes described in Section 1 of this bond ordinance are not current expenses. They are improvements or purposes the County may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property benefitted thereby.

B. The average period of usefulness of the improvements for which the obligations authorized by this Ordinance are to be issued is thirty (30) years.

C. The supplemental debt statement provided for in N.J.S.A. 40A:2-10 was duly filed in the Office of the Clerk of the Board of Chosen Freeholders prior to the passage of this Ordinance on first reading, and a complete executed duplicate of such supplemental debt statement has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey, and such supplemental debt statement shows that the gross debt of the County as defined in N.J.S.A. 40A:2-43 is increased by this Ordinance by \$53,700,000 and the obligations authorized by this Ordinance will be within all debt limitations prescribed by said Local Bond Law.

SECTION 11. In the event the monies set forth above for any purpose is not necessary for said purposes, then such monies shall be for the completion of any of the other purposes provided for in this Ordinance.

SECTION 12. The full faith and credit of the County of Ocean shall be pledged to the payment of the principal of and interest on the bonds and notes authorized by this Ordinance, and as long as any of said bonds or notes are outstanding, an appropriation shall be included in each annual budget of the County hereafter adopted in an amount sufficient to pay the principal of and interest on such bonds or notes maturing in each year. The obligations shall be direct, unlimited obligations of the County, and the County shall be obligated to levy ad valorem taxes upon all the taxable real property within the County for the payment of the obligations and the interest thereon without limitation as to rate or amount.

SECTION 13. After passage upon first reading of this Ordinance, the Clerk of the Board of Chosen Freeholders is hereby directed to publish the full text of the Ordinance, together with the notice set forth below entitled; "NOTICE OF PENDING ORDINANCE" (with appropriate completions, insertions and corrections), at least once in a newspaper qualified under N.J.S.A. 40A:2-19, at least seven days prior to the date set for public hearing and further consideration for final passage (which date shall be at least ten days after introduction and first reading). The Clerk of the Board of Chosen Freeholders is further directed to comply with all provisions of N.J.S.A. 40A:2-17(b) regarding postings, publications, and the provision of copies of this Ordinance.

SECTION 14. WHEREAS, recent delays in the federal government's plan to bring a new Veterans Administration clinic to Ocean County are unacceptable as the need increases significantly to replace the aging James J. Howard VA Clinic in Brick Township, and

WHEREAS, the VA clinic in Brick Township, has reached its capacity and while it provides invaluable services to our veterans, it can no longer handle the increasing numbers of veterans using the facility, and

WHEREAS, Ocean County is working closely with Congressman Chris Smith, who is the senior member of the New Jersey Congressional delegation and Congressman Andy Kim to put the project back on track and expedite the building of a new VA facility in Ocean County, and

WHEREAS, having this facility in Ocean County is critical for the care of our veterans, many of whom are elderly and frail.

NOW, THEREFORE BE IT RESOLVED that Ocean County calls upon the federal government to end the needless delays in moving forward with a new VA Clinic to be located in Ocean County.

BE IT FURTHER RESOLVED that the Ocean County Board of Chosen Freeholders pledges to work with Congressmen Smith and Kim to assist in any way to expedite the process of building a new VA clinic in Ocean County.

WHEREAS, with almost 40-miles of the Garden State Parkway running through Ocean County, and limited transportation options, commuters in the County will be among the hardest hit by toll increases approved by the New Jersey Turnpike Authority and Governor Murphy; and

WHEREAS, these toll increases will most assuredly provide money for projects on roads in Northern counties of the State delivering no significant benefits for Ocean County or the tens of thousands of tourists that visit the area; and

WHEREAS, clearly, Ocean County, one of the top users of the Parkway, should be given a voice on the New Jersey Turnpike Authority in order to represent our commuters and motorists; and

WHEREAS, an Ocean County resident should be tapped to fill the current vacancy on the New Jersey Turnpike Authority; and

WHEREAS, the State Legislature should consider a New Jersey income tax deduction for commuters who pay at least \$500 in toll costs per year as verified by EZ Pass in order to offset traveling expenses for Ocean County commuters.

BE IT FURTHER RESOLVED that certified copies of this resolution shall be made available to Governor Phil Murphy and the New Jersey Turnpike Authority.

Freeholder Director Joseph Vicari opened the meeting at 4:00 PM and read the Statement of Compliance with the Open Public Meetings Act. The Clerk of the Board called the roll.

Freeholder Director Vicari opened the meeting by discussing the Coronavirus and the importance of containment. Freeholder Little thanked Freeholder Director Vicari for bringing the Departments together to conquer the spread of the virus. Dan Regenye, the County Public Health Coordinator offered an update on the Coronavirus. Mr. Regenye told the Board that he met with the Sheriff's Department, local hospitals, the Warden, Superintendent of Schools, Senior Services Director Maria LaFace, CHEMED, and BMG (which is the largest Yeshiva in the country), to discuss proactive measures such as increased hand washing, which will prove to keep residents safe. Seniors and people with compromised immune systems seem to be the most at risk.

Freeholder Quinn mentioned that Ocean Ride will continue to provide safe travel and deliver supplies as well. The Freeholder felt that the County is in control of implementing the procedures set forth by the Health Department to keep residents safe. Freeholder Kelly said there are practices put into effect in the Jail to limit contact and the possible spread of the virus. Mr. Block added that they are adapting to the situation as it evolves each day. The Sheriff has also been meeting with the Courts to discuss new protocol as well.

Freeholder Little mentioned the importance of having one Health Department for the County in terms of efficiency and implementation of guidelines set forth by the CDC.

Joseph Meyers, Superintendent of Buildings and Grounds told the Board that they have increased the disinfection process at all of the 135 County buildings. They are disinfecting all communal surfaces such as elevators, door knobs, floors, and bathrooms nightly. Extra concentration will be given to the Southern Service Center due to the influx of senior residents.

Superintendent of Schools Kevin Ahearn, will approve submitted plans from each school district, and will continue to provide occupational therapy, physical therapy, and meals for low income students in the event of school closings.

Mr. Agliata and Freeholder Haines discussed a 1.69-acre Natural Lands Trust Fund Acquisition located at 12 Beach Avenue in the Good Luck Point section of Berkeley Township. The owner accepted a negotiated offer of \$239,000.00, which was well below the \$325,000.00 asking price. This property would add to the adjacent Hazard Mitigation project area.

Freeholder Quinn notified the Board of the upcoming 2020 Residential Document Shredding Program. Residents may bring up to 6 bags or boxes of documents to be shredded per event. Locations vary throughout the County, and the dates run through September, 2020.

Mr. Ernst reviewed the items listed on the attached Engineering Department agenda which included the recommendation to advertise for the reconstruction and resurfacing of Shorrock Street from Route 70 to Beaverson Blvd in Brick and Lakewood Townships. There were no questions or comments and all items will be listed on the Board Agenda for the March 18, 2020 Board meeting.

Ms. Cilento reviewed the Clerk of the Board's agenda for the Board meeting of March 18, 2020. There were no questions or comments.

Freeholder Director Vicari said the Tourism Advisory Board advised him that there is an increase in shore rentals from last year.






