Dear Mr. Agliata,

The New Jersey Department of Environmental Protection, Division of Sustainable Waste Management, Bureau of Planning and Licensing is in receipt of a request for administrative action to the Ocean County District Solid Waste Management Plan (County Plan) dated October 13, 2022. This amendment to the County Plan proposes County Plan inclusion to increase daily tonnages at the Ocean County Southern Recycling Center (OCSRC) for both Class B/C material and specifically the acceptance of woodchips located at the end of Haywood Road, Block 25, Lots 38 & 39 in Stafford Township.

The subject request also proposes County Plan inclusion to rectify certain inconsistencies between the OCSRC General Approval and the County Plan. Specifically, OCSRC is requesting the following modifications to the County Plan and match consistency with their Class B/C Recycling General Approval:

- OCSRC is a Multi-Class B & C Recycling Facility.
- OCSRC is located at the end of Haywood Road in Stafford Township, Block 25, Lots 38 & 39.
- OCSRC is authorized to accept brush, woodchips, and leaves.
- OCSRC is authorized to accept 175 tons per day (tpd) of brush/woodchips and 175 tpd of leaves. This represents an increase of 75 tpd increase for both brush/woodchips and leaves.
- OCSRC is authorized to accept leaves, brush, & woodchips from 7:30am-3:00pm Monday-Saturday (Saturdays for residents only, no businesses).

Pursuant to N.J.A.C. 7:26-6.11(b)4, the inclusion for increase of capacity of any size of any existing facility; and N.J.A.C. 7:26-6.11(b)14, to rectify certain inconsistencies between the OCSRC General Approval and the County Plan can be accomplished via an administrative action. Therefore, the County Plan inclusion to increase capacity and update certain inconsistencies, is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).

The Ocean County Department of Solid Waste Management is applying for modifications to the Multi-Class General Approval for operations at its Southern Recycling Center (Facility ID No. 133644, Block 25, Lots 38 & 39, Stafford Township), in order to increase allowable daily tonnages for both Class B & C material and allow for the acceptance of woodchips. In addition to these proposed modifications, we have been advised by your Department that an Administrative Action should clarify the following information:

- The Ocean County Southern Recycling Center is a Multi-Class B & C Recycling Facility.
- Facility is located at the end of Haywood Rd. in Stafford Twp., New Jersey Block 25, Lots 38 & 39.
- Facility is authorized to accept brush, woodchips, and leaves.
- Facility is authorized to accept 175 tons of brush/woodchips per day and 175 tons of leaves per day.
- Facility is authorized to accept leaves, brush, & woodchips from 7:30am-3:00pm Monday-Saturday (Saturdays for residents only, no businesses)

This Administrative Action serves to incorporate the above information, and proposed increase in allowable daily tonnages at the Southern Recycling Center, within the Ocean County District Solid Waste Management Plan pursuant to <u>N.J.A.C.</u> 7:26-6:11(b)4 and <u>N.J.A.C.</u> 7:26-6:11(b)11 (subject to your Department's approval).
