Director Barbara Jo Crea opened the meeting at 4:00 PM and read the Statement of Compliance with the Open Public Meetings Act. The Clerk of the Board called the roll.

Present:

Michael J. Fiure, County Administrator Christine Allen, Recording Secretary Michelle I. Gunther, Clerk of the Board John C. Sahradnik, Jr., County Counsel

Commissioner Haines and Michael Fiure discussed the County Option Hospital Fee Program for the purpose of increasing Federal Medicaid payments to local hospitals to allow Medicaid patients the same access to healthcare and providing Counties with new fiscal resources.

Philip Pesses, Chief Administrative Officer for RWJ BH Monmouth Medical Southern Campus and Teri Kubiel, VP of Community Affairs for RWJ BH discussed the importance of lower income patients' ability through this program, to access advanced care such as cancer screenings. Navigators in each hospital work with the Board of Social Services to connect patients with the proper providers.

Michael Fiure stated that the County participated in the program for the first time in 2023, with a financial benefit of \$2,044,488.00. County hospitals paid fees totaling \$22,716,527.00. The remainder was matched with federal dollars and resulted in payments to Ocean County hospitals in the amount of \$63,214,214.00. A net gain of \$40,497,687.00.

Commissioner Haines and Mr. Agliata discussed several items on this week's agenda pertaining to the design and construction of the Barnegat Branch Trail Phase VIII in Barnegat and Berkeley Townships, Phase IX in South Toms River, Phase XI in Beachwood and the Hickory Lane Trailhead in Berkeley Township. When construction is completed, the entire length of the trail will be approximately 16 miles.

Commissioner Kelly and Mr. Jehnke reviewed the items listed on the attached Engineering Department agenda which included three recommendations to award contracts. The first is for the construction of the Barnegat Branch Trail Phase IX, No. II, Admiral Avenue to S. Main Street and Herflicker Blvd. in Beachwood and South Toms River Boroughs to Grade Construction from Paterson, NJ in the amount of \$944,389.69. This award is contingent upon NJDOT approval. The second recommendation is for Stormwater Management Improvements Contract 2023B in various townships to Black Rock Enterprises, LLC from Old Bridge, NJ in the amount of \$1,015,425.80. The third is for Stormwater Management Contract 2023C in various townships to Earle Asphalt Company from Farmingdale, NJ in the amount of \$1,399,813.13. Mr. Jehnke met with Mayors on LBI regarding traffic lights on Long Beach Blvd. The light at 28<sup>th</sup> Street will always remain fully functional. 80<sup>th</sup> Street in Harvey Cedars had a blinking signal when a fatal accident occurred there. The signal will now be fully functional. There will not be an additional traffic signal added to 31<sup>st</sup> Street because both Mayors do not agree on the proposed additional signal. There were no questions or comments, and all items will be listed on the Board Agenda for the November 6, 2024 Board meeting.

Ms. Gunther reviewed the Clerk of the Board's agenda for the Board meeting of November 6, 2024. There were no questions or comments.

Director Crea asked the Board members for comments.

Commissioner Haines said Paul Hulse from Just Believe will be running the new Code Blue Shelter in South Toms River.

There were no additional comments.

Mr. Fiure notified the Board that he will be preparing a resolution and a letter to Governor Murphy opposing NJ PACT (Protecting Against Climate Threats) / REAL (Resilient Environments and Landscapes). If this law is put into effect, it will inhibit new construction on the coastline, and all new projects (County included) will have to meet new criteria. Mr. Flure will be requesting an economic impact study, maps, and a public engagement session.

Ms. Gunther read the resolution to move to closed session.
