- 4. Program Update: 30,055 acres
 - Closings:
 - o#734 Pine Lake Park Correia, Manchester Twp., 0.27 acres Mr. Palmieri informed the Committee that we closed on a nomination directly adjacent to our Pine Lake Park Transfer preserve. This property was a donation and brings the total preserved acreage to 30,055. Mr. Fox mentioned that Ocean County now has 46.9 square miles preserved.

5. Old Business

- Old Business:
 - o#594 Roosevelt City Inholding Harrison LLC, Manchester Twp., 1.01 acres This nomination is located in the Manchester Township Roosevelt City area near Ocean County's Structural Management preserve. Negotiations in the past led the property owner to reject any offers due to the desired asking price. The property owner has returned the nomination with an asking price of \$40,000.00. The Advisory Committee were not in favor of the nomination for the requested asking price and advised staff to move the property to hold.
 - o #593 Jeffreys Creek Sonntag, Berkeley Twp., 2.31 acres The next nomination located in Berkeley Township was initially reviewed at the February meeting. There was no outside interested buyers and the owner has preliminary major approval for two three-story townhouse buildings with a total of seventeen units. The asking price was \$1,615,000.00 and assessed at \$400,000.00. The Advisory Committee was not in favor of the

nomination due to the high asking price and advised staff to move the property to hold.

o#635 Birch Street, Beachwood Borough, 3 acres — This nomination was also on February's meeting. The Advisory Committee's recommendation was to move the property to hold due to the nature of the asking price and the location of the property. The property owner had requested the Advisory Committee re-review the property one last time. The Advisory Committee remained with their initial decision and advised staff to move the property to hold.

6. New Business

- New Business:
 - o#621 Golden Holdings, Eagleswood Twp., 77 acres The first new nomination located in Eagleswood Township was previously nominated under the program, however was moved to hold due to lack of township support. Recently, Eagleswood Township passed a resolution of support for Ocean County to include the property into the preservation program. There are no approvals to currently develop the property, however the owner mentioned that there were national home builders who are prepared to pursue entitlements to fit 149 single-family homes on the property. The asking price is \$2,600,000.00 and assessed at \$745,100.00. The Advisory Committee was not in favor of the asking price for the property and advised staff to pass on the nomination.
 - o#757 Manchester Ave Fortunato, Manchester Twp., 0.06 acres This nomination is an inholding located in our Cleveland Street preserve. The property owner is seeking \$5,000.00 and is assessed at \$1,200.00. The Advisory Committee were not in favor of purchasing this piece, however they requested staff to gauge the property owner's interest in a donation.

#763 Westray Ave., Island Heights Borough, 1.29 acres
A **MOTION** was made by Mr. Mangum and seconded by Mr. Peterson to recommend to
the Board of Commissioners the fee simple acquisition of the Westray Ave property
under the Ocean County Natural Lands Trust Fund, 1.29 acres in Island Heights Borough
for an amount not to exceed \$1,175,000.00. Roll was called, all in favor, motion carried.
