The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a request for administrative action to the Ocean County District Solid Waste Management Plan (County Plan) dated June 18, 2025. This amendment to the County Plan proposes County Plan inclusion of revised block and lot for Rubbercycle, LLC, located at 1985 Rutgers University Boulevard in the Township of Lakewood. The request proposes to correct a clerical error and change the block and lot from Block 1609, Lot 2802 to Block 1609, Lot 28.02.
