INSTRUCTIONS FOR VOTING

- The Board Worker will hand you a ballot card and a voting authority; DO NOT FOLD THE BALLOT CARD. Take the card to the voting machine and insert with the cut side to the top right.
- A language selection appears on the screen, follow the prompts by touching the screen for English or Spanish.
- Choose "Start Voting", then make your selections by touching the candidate's name of your choice on the screen.
- If you need to view the ballot or any contest in a larger font, touch "TEXT SIZE" and then touch "LARGE TEXT" and then touch "RETURN TO BALLOT".
- To vote for a person whose name is not shown, touch the "WRITE IN" box in the "PERSONAL CHOICE" column and type in the candidate's name on the keyboard shown on the screen. Touch "ACCEPT".
- Review all selections on the ballot screen. To make a change, touch the contest (name of candidate) and make a selection.
- Touch "PRINT BALLOT". A pop-up window will be displayed giving you the options to either "PRINT" or "RETURN TO BALLOT".
- Touch "PRINT" if you want to continue casting your vote.
- The machine prints the ballot and displays it in the window to the right for you to review, giving you the option to either "CAST" or "QUIT". If you are satisfied with the ballot, touch "CAST". The ballot card is then deposited in a secure card container. If you choose "QUIT", the machine will return the ballot card to you and will direct you to seek the help of a poll worker.

BEFORE ENTERING THE MACHINE, IF YOU HAVE ANY QUESTIONS ABOUT VOTING, ASK THE POLL WORKER.

INSTRUCCIONES PARA VOTAR

- El Trabajador de la Junta de Elecciones le entregará una boleta y una autorización para votar; NO DOBLE LA BOLETA. Llévela a la máquina de votación e introdúzcala con el lado cortado hacia la parte superior derecha.
- En pantalla aparece la selección del idioma; siga las indicaciones tocando la pantalla para inglés o español.
- Elija "Start Voting" (Empezar a votar) y, a continuación, seleccione sus preferencias tocando en la pantalla el nombre de los candidatos de su elección.
- Si necesita ver la boleta o cualquier concurso en una letra más grande, toque "TEXT SIZE" (TAMAÑO DE TEXTO) y después toque "LARGE TEXT" (TEXTO GRANDE) y después toque "RETURN TO BALLOT" (VOLVER A LA BOLETA).
- Para votar por una persona cuyo nombre no aparece, toque la casilla "WRITE IN" (ESCRIBIR SU VOTO) en la columna "PERSONAL CHOICE" (ELECCIÓN PERSONAL) y escriba el nombre del (la) candidato(a) usando el teclado que aparece en la pantalla. Toque "ACCEPT" (ACEPTAR).
- Revise todas sus selecciones en la pantalla de la boleta. Para hacer un cambio, toque el concurso [nombre del (la) candidato(a)] y seleccione un(a) candidato(a).
- Toque "PRINT BALLOT" (IMPRIMIR BOLETA). Aparecerá una ventana emergente que le dará las opciones de ya sea "PRINT" (IMPRIMIR) o "RETURN TO BALLOT" (REGRESAR A LA BOLETA).
- Toque "PRINT" (IMPRIMIR) si desea continuar emitiendo sus votos.
- La máquina imprime la boleta y la muestra en la ventana situada a la derecha para que usted la revise, dándole la opción ya sea de "CAST" (EMITIR VOTO) o "QUIT" (SALIR). Si está satisfecho(a) con la boleta, toque "CAST" (EMITIR VOTO). La boleta se depositará en un contenedor seguro de boletas. Si elige "QUIT" (SALIR), la máquina le devolverá la boleta y le indicará que solicite la ayuda de un trabajador electoral.
