The New Jersey Department of Environmental Protection, Division of Sustainable Waste Management, Bureau of Planning and Licensing is in receipt of a request for administrative action to the Ocean County District Solid Waste Management Plan (County Plan) dated November 22, 2022. This amendment to the County Plan proposes County Plan inclusion to incorporate a change in designation at the Brick Township Public Works Facility (Brick) located at Block 1442, Portion of Lots 4, 20, and 21, in the Township of Brick to rectify certain inconsistencies in their application to modify their Recycling Center General Approval (GA) and the County Plan. These changes include the following:

- *Brick is open Monday- Saturday, 6:30am to 3:30pm.
- *Brick is authorized to accept brush and leaves.
- *Brick is authorized to accept 25 tons of brush and 25 tons of leaves daily.
- *Brick is authorized to accept 7,800 tons of brush and 7,800 tons of leaves, annually.

Pursuant to N.J.A.C. 7:26-6.11(b)14, to rectify certain inconsistencies between the Brick GA and the County Plan can be accomplished via an administrative action. Therefore, this request is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).

A request has been made by the **Township of Brick**, dated November 18, 2022, to amend the Ocean County District Solid Waste Management Plan (County Plan) in recognition of their application to modify their Recycling Center General Approval. The **Brick Township Public Works Facility** (located at *Block 1442, Portion of Lots 4, 20, & 21*) has maintained designation in the County Plan as a Class C Recycling Center since 1992, and has relied upon recycling exemptions for select Class B recycling activities (brush) to take place onsite. In response to notifications indicating they may no longer utilize exemptions at this location, Brick Township is applying for a Multi-Class (B & C) Approval and concurrently requesting a change to their designation within the County Plan. There will be no significant changes to Class B & C operations at the facility, which are as follows:

- Facility is open Monday-Saturday, 6:30 AM to 3:30 PM.
- Facility is authorized to accept brush and leaves.
- Facility is authorized to accept 25 tons of brush and 25 tons of leaves daily.
- Facility is authorized to accept 7,800 tons of brush and 7,800 tons of leaves annually.

The requested modification is acceptable to the County and accomplishable via Administrative Action pursuant to N.J.A.C. 7:26-6:11. This letter shall serve as an Administrative Action to modify the Ocean County District Solid Waste Management Plan to incorporate a change in designation for the **Brick Township Public Works Facility**, subject to the Department's approval.
