The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Planning and Licensing is in receipt of a request for administrative action to the Ocean County District Solid Waste Management Plan (County Plan) dated August 11, 2022. This amendment to the County Plan proposes County Plan inclusion of a change in name of the former Walter R. Earle Corporation (Walter Earle) Class B Recycling Center to Pure Soil Technologies, Inc.
