The New Jersey Department of Environmental Protection's Division of Sustainable Waste Management, Bureau of Solid Waste Planning and Licensing is in receipt of a proposed amendment to the Ocean County District Solid Waste Management Plan (Plan) dated June 19, 2024. This amendment to the County Plan proposes to incorporate the following operations regarding Recycling of Central New Jersey, LLC into the County Plan. The facility is located on Block 14.19, Lot 1 and Block 14.15, Lot 25, 577 S. Hope Chapel Road in the Township of Jackson. The operating hours for this facility are Monday through Saturday, 7:00 A.M. to 7:00 P.M. The accepted materials are concrete, asphalt, tree stumps, and wood (specifically unpainted and non-chemically treated). The daily tonnage limit for this facility is 1,600 tons, divided as follows: 500 tons of concrete per day, 500 tons of asphalt per day, 500 tons of tree stumps per day, and 100 tons of untreated wood (specifically unpainted and non-chemically treated) per day.

Pursuant to N.J.A.C. 7:26-6.11(b)14, the clarification of operations details in the Ocean County Solid Waste Management Plan can be accomplished via administrative action. Therefore, the County Plan clarification is hereby approved as an Administrative Action pursuant to N.J.A.C. 7:26-6:11.

Ocean County has received a revised request from Recycling of Central Jersey, LLC, dated June 18th 2024, to amend our District Solid Waste Management Plan (County Plan) to clarify information about their facility operations. This letter shall therefore establish the following within the County Plan:

- 1.) The name of this facility is Recycling of Central Jersey, LLC.
- 2.) Operating hours are Monday-Saturday, 7:00 AM to 7:00 PM.
- 3.) Accepted materials are concrete, asphalt, tree stumps, and untreated wood waste.
- 4.) The daily tonnage limit for this facility is 1,600 tons, divided as follows: 500 tons concrete per day, 500 tons asphalt per day, 500 tons tree stumps per day, 100 tons untreated wood waste per day.
- 5.) The associated block and lot for this facility is Block 14.19, Lot 1 and Block 14.15, Lot 25, Jackson Township.

The County hereby includes the above within the Ocean County District Solid Waste Management Plan as an Administrative Action, pursuant to N.J.A.C. 7:26-6:11.
