Course Descriptions

AMBULANCE STRIKE TEAM LEADER

This instructor-led course will train students in the roles and responsibilities of the Ambulance Strike Team Leader in a large-scale incident. This course will cover the supervisory responsibilities during mobilization, deployment, and demobilization. It will also cover accountability of personnel and equipment, risk assessment, management, and documentation of their missions. Lastly, sample Incident Action Plans involving a jurisdiction confronted with large numbers of patients requiring ambulance transportation will be reviewed.

CEU's: 8

Course Length: 8 Hours

Prerequisite: ICS 100, ICS 200, NIMS 700, LSI Awareness

EMERGENCY INCIDENT REHABILITATION

This course reviews the necessity for rehab, the concept of rehab, and the importance of rehab to all emergency services including environmental conditions. It also provides consideration for placement of the rehab sector, medical evaluations, and transportation considerations.

CEU's: 4

Course Length: 4 Hours

Prerequisites: None

EMERGENCY RESPONSE TO DOMESTIC BIOLOGICAL INCIDENTS

Emergency Response to Domestic Biological Incidents is a performance-level course designed to help participants safely and effectively respond to a biological incident by using an integrated approach. The course provides detailed information about various biological agents and possible methods of dissemination - whether naturally occurring or intentional. Participants will identify appropriate assessment and response actions and will review responder health and safety practices, containment measures, and tools that may be accessed during a biological incident. Course Length: 16 Hours

Prerequisites: None

Course Descriptions

EMS RESPONSE TO LARGE-SCALE INCIDENT: LEVEL 2 OPERATIONS

The purpose of this course is to provide EMS personnel, and guests, with a standardized method toward recognizing and implementing initial actions at the scene of a Large-Scale Incident. This course will provide the participant with the skills necessary to quickly size up the event and obtain the necessary resources for the successful mitigation and resolution of the Large-Scale Incident. While the awareness level provides an overview experience, the operational level is designed for those who actively respond to incidents and would benefit from the more in-depth education experience.

CEU's: 16

Course Length: 16 Hours

Suggested Prerequisite: ICS 200, EMS Response to LSI Level 1 Awareness

ENVIRONMENTAL EMERGENCIES

This program discusses common environmental conditions, such as frostbite, hypothermia, heat stroke and recreational events, and other winter/summer-related emergencies.

CEU's: 3

Course Length: 3 Hours

Prerequisite: None

FUNDAMENTALS OF AIRWAY MANAGEMENT

Fundamentals of Airway Management is a one-day course designed for Basic and Intermediate EMS providers and other medical professionals who may be required to manage a patient's airway before transport to a hospital. This course can also be tailored for dentists and office-based physicians.

CEU's: 8

Course Length: 8 Hours

Prerequisite: None

Course Descriptions

GEMS - GERIATRIC EDUCATION FOR EMS PROVIDERS

NAEMT's Geriatric Education for EMS course prepares prehospital practitioners to respond to, assess, and care for this fast-growing patient population. This course helps EMS practitioners learn to conduct a comprehensive assessment of geriatric patients. Because the aging process affects all body systems, NAEMT's course provides an overview of changes that occur as people age and describes how those changes can impact patient presentation. Incorporation of the **GEMS Diamond** (Geriatric, Environmental, Medical, and Social assessments) can help practitioners formulate a holistic diagnostic and treatment approach.

CEU's: 8

Course Length: 8 Hours

Prerequisite: None

MEDICAL PREPAREDNESS AND RESPONSE FOR BOMBING INCIDENTS (TEEX - MGT 348)

This course is intended for members of emergency response as well as other city and county services that become a part of a community response to a bombing incident. This interactive, Instructor-facilitated program employs case studies, lessons learned, validated medical data, and potential threats to the communities we serve. Sessions will address planning considerations and concerns specific to medical responders, law enforcement, and emergency planners, with an intended outcome of integrating incidents of an explosive nature to existing plans. This will enhance community preparedness by identifying areas to address when attendees return to their jurisdiction.

CEU's: 16

Course Length: 16 Hours

Prerequisite: None

Course Descriptions

MENTAL HEALTH RESILIENCE OFFICER (NAEMT)

The Mental Health Resilience Officer (MHRO) course prepares EMS personnel to serve as their agency's Mental Health Resilience Officer. In this role, the MHRO will engage with peers to develop an understanding of mental health issues and resilience: identify peers who are experiencing mental health stressors and crises; navigate peers in need to the right services for help; and support the development of a culture of mental health resilience and emotional wellness within the agency.

CEU's: 8

Course Length: 8 Hours

Prerequisite: None

NJ DEAF AND HARD OF HEARING

NJ Deaf and Hard of Hearing will host a 1.5 hour seminar for the First Responder community. This class will teach responders on how to interact with those who are hard of hearing the way communications should occur and the devices used for the hard of hearing.

CEU's: 1.5

Course Length: 1.5 Hours

Prerequisite: None

Course Descriptions

NJ EMT REFRESHER

NJ EMT's must successfully complete both a 24-hour EMT Refresher program broken into three 8-hour blocks (A, B, and C) and 24 elective CEU credits as well as maintain current BLS CPR certification. Moreover, the Refresher Courses receive NJ OEMS approval for the renewal of NJ Emergency Medical Technicians.

The goal of this course is to review common skills employed by EMTs while responding to 911 calls for emergency medical assistance, such as cardiopulmonary resuscitation (CPR) or bandaging a wound. Additionally, participants will employ patient assessment skills to determine the best course of treatment. So that participants may continue to provide appropriate first-aid treatment or life support care to sick or injured patients.

Intended Audience: NJ EMT's looking to recertify their credential and expired EMT's looking to obtain the NREMT skills competency to challenge the exam.

Prerequisites: Current BLS/CPR card

NJ REFRESHER A COURSE

Topics include airway management, assisted and artificial ventilation, CPAP protocols, oxygen administration, patient assisted and administered medications, respiratory distress protocols, and respiratory emergencies

NJ REFRESHER B COURSE

Topics include cardiac, endocrine, GI/GU immunologic, neurologic, OB/GYN, and respiratory, emergencies. Additionally, we review patient assisted and administered medications and BLS CPR skills

Course Descriptions

NJ REFRESHER C COURSE

Topics include abdominal, chest, head and neck, orthopedic, soft tissue injuries and bleeding control. We review and assess your bleeding control and bandaging as well as splinting skills.

TACTICAL EMERGENCY CASUALTY CARE (TECC)

The Tactical Emergency Casualty Care (TECC) program is based on the principles of Tactical Combat Casualty Care (TCCC) and meets the guidelines established by the Committee on Tactical Emergency Casualty Care (CoTECC). The course teaches civilian tactical EMS; any practitioner called upon to respond to a mass casualty or active shooter event.

CEU's: 16

Course Length: 16 Hours
