WHEREAS, the Ocean County Board of Chosen Freeholders has adopted and the Commissioner of the New Jersey Department of Environmental Protection has certified, as required by law, a Solid Waste Management Plan for the Ocean County Solid Waste Management District; and

WHEREAS, the Ocean County Board of Chosen Freeholders has adopted amendments to the Solid Waste Management Plan to provide a comprehensive strategy for the management, recycling and disposal of solid waste generated within the Ocean County Solid Waste Management District; and

WHEREAS, Tri-State Recycling Services, Inc. submitted an application on August 14, 2014 to be recognized as a Class A recycling facility to process and bale a maximum of 60 tons of their own collected cardboard and paper a day at Block 863, Lots 5.01, 5.02, 18.01, 20, 21, and 22, 204 Hickory Lane, Berkeley Township; and

WHEREAS, Ocean County's Department of Solid Waste Management reviewed the application and determined that it is complete; and

WHEREAS, Tri-State Recycling Services, Inc. has presented their plans to the Ocean County Solid Waste Advisory Council, and notified the public, municipal clerk and NJDEP; and

WHEREAS, Tri-State Recycling Services, Inc. published two notices of the proposal in the Asbury Park Press on September 19th and 26th, and no public comments were received; and

WHEREAS, the Ocean County Solid Waste Advisory Council recommended on November 17, 2014, to the Ocean County Board of Chosen Freeholders that Tri-State be included in the Ocean County District Solid Waste Management Plan; and

WHEREAS, the Ocean County Board of Chosen Freeholders have carefully considered the recommendations of the Ocean County Solid Waste Advisory Council.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN
FREEHOLDERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as
follows:**

1. Tri-State Recycling Services, Inc. is hereby included in the Ocean County District Solid Waste Management Plan as a Class A recycling facility as described in their August 14, 2014 application, subject to the following conditions:
 - a. The only material that will be accepted is cardboard, mixed paper and sorted office paper delivered by Tri-State Recycling Services, Inc. and Tri-State Carting Inc. vehicles. Any material from another company or source is not permissible.
 - b. The material that is to be baled is only cardboard, mixed paper and sorted office paper.
 - c. The total maximum amount of cardboard, mixed paper and sorted office paper to be accepted is not to exceed 60 tons per day.
 - d. All materials must be stored in doors.
2. Copies of this resolution shall be provided to the Director of the Department of Solid Waste Management, County Counsel, Tri-State Recycling Services, Inc., New Jersey Department of Environmental Protection and Ocean County Health Department



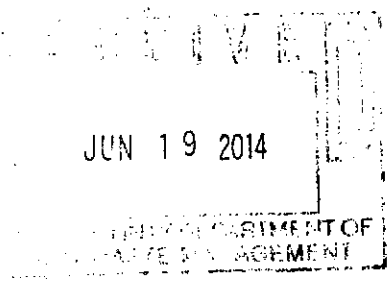



The Department of Environmental Protection's Division of Solid and Hazardous Waste is in receipt of a December 23, 2014 proposed amendment to the Ocean County District Solid Waste Management Plan (County Plan). This amendment, adopted by the Ocean County Board of Chosen Freeholders through Official Resolution 2014001403, proposes County Plan inclusion of Tri-State Recycling Services, Incorporated, Class A Recycling facility, to be located on Block 863, Lots 5.01, 5.02, 18.01, 20, 21, and 22, at 204 Hickory Lane in the Township of Berkeley. The subject recycling facility is proposed to be included in the County Plan for the acceptance of a maximum of 60 tons per day of Class A recyclables (paper and cardboard) from 7:00 am – 5:00 pm, Monday through Saturday.

Although initiated as a plan amendment, pursuant to N.J.A.C. 7:26-6.11(b)3, the inclusion of a Class A facility constitutes an approvable administrative action. Therefore, the subject December 23, 2014 County Plan amendment is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
