





WHEREAS, Ocean County's 521 RSVP Volunteers provided over 23,000 hours of volunteer service to 34 organizations in 2014; and



ORDINANCE #2015-7

AN ORDINANCE AUTHORIZING THE RECONSTRUCTION OF HOPE CHAPEL ROAD (COUNTY ROAD 547 AND COUNTY ROAD 639) FROM COOKS BRIDGE ROAD TO MILLER ROAD, LOCATED IN JACKSON AND LAKEWOOD TOWNSHIPS, COUNTY OF OCEAN, STATE OF NEW JERSEY, AND APPROPRIATING \$3,000,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$2,850,000 IN BONDS OR BOND ANTICIPATION NOTES OF THE COUNTY OF OCEAN TO FINANCE THE SAME.

BE IT ORDAINED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF OCEAN, IN THE STATE OF NEW JERSEY (NOT LESS THAN TWO THIRDS OF ALL MEMBERS THEREOF AFFIRMATIVELY CONCURRING) AS FOLLOWS:

SECTION 1. There is hereby authorized to be undertaken by the County of Ocean as general improvements, a project consisting of the reconstruction of Hope Chapel Road (County Road 547 and County Road 639) from Cooks Bridge Road to Miller Road, located in Jackson and Lakewood Townships, in the County of Ocean, State of New Jersey, in accordance with plans and specifications on file in the Ocean County Engineering Department, including all else necessary therefor and incidental thereto.

SECTION 2. It is hereby found, determined and declared that the improvements or purposes, the estimated cost of the improvements and appropriation therefor, down payment and estimated maximum amount of bonds or notes authorized are as follows:

The obligations shall be direct, unlimited obligations of the County, and the County shall be obligated to levy ad valorem taxes upon all the taxable real property within the County for the payment of the obligations and the interest thereon without limitation as to rate or amount.



WHEREAS, the Attorney General of the State of New Jersey and the Division of Local Government Services have determined that active sworn officers of the Sheriff's Department may, during their off-duty hours, engage in police related activities for "Rules and Regulations for the Outside Employment of Off-Duty Sheriff Officer's, and

WHEREAS, in order to ensure that the County is paid for these services, and that the assignments to outside contractors do not conflict with the needs of the County, it is appropriate to establish hourly rates and procedures to be followed by "Rules and Regulations for the Outside Employment of Off-Duty Sheriff Officer's and the Ocean County Sheriff's Department.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF CHOSEN FREEHOLDERS, COUNTY OF OCEAN, AND STATE OF NEW JERSEY, as follows:

1. The County of Ocean hereby establishes the "Rules and Regulations for the Outside Employment of Off-Duty Sheriff Officer's" as set forth in Exhibit A attached hereto and incorporated herein.

2. The County of Ocean authorizes the Ocean County Sheriff to execute any all necessary documents and Agreements necessary to implement and effectuate the Outside Employment of Off-Duty Sheriff Officers.

3. Copies of this Resolution shall be kept on file and made available for public inspection in the Office of the Clerk of the Board during normal business hours.

EXHIBIT A.

COUNTY OF OCEAN

Rules and Regulations for the Outside Employment of Off-Duty Sheriff

Officer's

1. Extra-duty employment of Sheriff's officers.

- A. To accommodate those persons and entities requiring the services of off-duty Sheriff's officers and to authorize their off-duty employment, the County hereby establishes this policy and procedures.
- B. Sheriff's Officers deemed eligible by the Sheriff to do so shall be permitted to accept law-enforcement-related employment from nongovernmental employers and school districts only during their off-duty hours and at such times as will not interfere with the efficient performance of regularly scheduled or emergency duty for the County.
- C. Persons or entities wishing to employ off-duty Sheriff's officers must make their request through the Sheriff. The Sheriff may grant such request when, in his/her opinion, such employment will not be inconsistent with the efficient functioning and good reputation of the Sheriff's Office and would not unreasonably endanger or threaten the safety of the officer(s) who will be working the assignment(s).

2. Requests for Services.

- A. Any person or entity seeking to employ off-duty Sheriff's officers shall first obtain the approval of the Sheriff or his/her designee. The Sheriff or his/her designee is authorized to execute an agreement with the applicant for services needed, which agreement shall set forth the specific nature of the services to be performed, the location, dates and hours of service, payment arrangements mandated herein, number of officers needed, insurance coverage and/or any other provisions required by law or regulation of the State of New Jersey. The applicant must first file a request for services with the Sheriff's Outside Employment Unit ("OEU"). The applicant must include in the request for services evidence that the Chief Law Enforcement Officer of the local municipality is unable or unwilling to provide off-duty officers.
- B. Any Sheriff's officer, when so employed by any person or entity, shall be treated as an employee of that person or entity. Any and all wages earned for outside employment shall not be applied toward the pension benefits of Sheriff's officers so employed, nor shall hours worked for outside employment be considered in any way compensable as overtime under the Fair Labor Standards Act or compensable in any other manner that requires the County to pay the officers by County funds through its payroll system. All Sheriff's officers shall be subject to the policies, procedures, directives, rules and regulations of the Sheriff, the Ocean County Prosecutor's office and the Attorney General's Office of the State of New Jersey.

3. Billing/payment schedule/escrow accounts.

Billing periods. Billing and payment practices for persons or entities contracting for the provision of security services by off-duty Sheriff's officers shall be conducted in accordance with local finance laws and regulations promulgated by the Local Finance Board.

- A. The County has established an escrow account dedicated to the payment of off-duty Sheriff's Officers for outside employment by private contractors. Any prospective contractor must apply to the Sheriff, requesting off-duty police services. The written application shall include the following information:
- i. The dates that off-duty police services and police vehicle(s) will be needed.
 - ii. An estimate of the number of hours the contractor anticipates using the off-duty police officer(s) and, if appropriate, police vehicles.
 - iii. A check to cover the cost of off-duty police services and use of any County vehicles based on the estimated number of hours shall be submitted before the start of off-duty employment in accordance with state and Division of Local Government services regulations.
- B. Prospective contractors who continuously request off-duty police service, or anticipate a need for periodic or long-term off-duty police services, may request to deposit monies with the County on an ongoing basis to be depleted as such work is performed. Funds on deposit shall not earn interest.
- C. If the contractor's needs exceed the estimated sum in the escrow account, the Sheriff, or his designee, shall immediately notify the contractor that the funds in the escrow account are insufficient to pay for continued off-duty police services. The contractor shall then either replenish the escrow account with a check sufficient to pay for continued services or the Sheriff shall immediately terminate provision of the off-duty police services to the contractor.
- D. If the contractor's estimated costs exceed the actual costs incurred, then the County shall, upon proper notice to the County Chief Financial Officer, refund the remainder of the escrow account.
- E. No Sheriff's Officer shall accept any payment in any form from any person or entity other than the County, and unless that payment has been formally and permanently documented by the Chief Financial Officer of the County. No person or entity shall give or channel any form of payment or gratuity to any Sheriff's Officer in connection with the services of off duty officers, but shall use the escrow account described in subsection A.

4. Rates of compensation; administrative fees; payment for services

Rates of compensation for contracting the services of off-duty Sheriff's officers shall be as follows:

- A. The rate of compensation for the contracting the service of off duty sheriff officers shall be a rate of \$65.00 per hour for each officer, of which \$15.00 per each hour shall be an administrative fee retained by the County.
- B. Four-hour minimum. All assignments shall have a four-hour minimum per officer contracted. Sheriff's officers are entitled to the four-hour minimum if the assignment is cancelled upon their arrival at the job site, without prior notice. Sheriff's officers who begin an assignment that is cancelled before its completion shall be entitled to the four-hour minimum or actual hours worked, whichever is longer.

5. Contractor obligations and limitations.

Persons or entities contracting for off-duty law enforcement services are placed on notice that the Ocean County Sheriff is the primary employer of Sheriff's

officers and, in contracting for such services, expressly agree to the following conditions:

- A. Police-related work. Sheriff's officers providing law enforcement services shall not be required to perform non-police-related tasks. Police-related tasks typically involve crowd/traffic control and site security.
- B. Uniforms. Unless specifically authorized by the Sheriff, Sheriff's Officers shall be in uniform. Requests from persons or entities for officers to work in a plain clothes' capacity shall be made in writing to the Sheriff, who in his/her sole discretion may approve or deny such a request for any or no reason.
- C. Cancellations. Persons or entities that have contracted for off-duty Sheriff's officers and wish to cancel must provide a minimum of two hours' notice or be subject to the four-hour minimum for each officer contracted.
- D. State of emergency. The Sheriff or his/her designee shall, at all times, have the authority to order any Sheriff's officer engaged in off-duty assignments to respond to an emergency situation. The Sheriff or his/her designee shall also have the right to order any off-duty assignment terminated whenever said assignment creates an unacceptable risk to the health, safety or welfare of the off-duty officer and/or the citizens of Ocean County.

6. Insurance requirements.

- A. Persons or entities contracting for off-duty law enforcement services are responsible for providing all insurance coverage as required by law. Each applicant shall provide the Ocean County Sheriff with appropriate certificates of insurance naming the County of Ocean and the Sheriff's officers as additionally insured and evidencing that the Sheriff's officer and Ocean County are covered by general liability coverage of at least \$1,000,000 for each occurrence with respect to the services to be provided.
- B. The certificate of insurance or the policy shall contain the following language: "The Insurer shall indemnify, defend and hold harmless the County of Ocean and Ocean County Sheriff, their employees, agents, servants, officials and administrators from and against any and all claims, or actions at law, whether for personal injury, property damage or liability including any costs of defense incurred by the County of Ocean and/or Ocean County Sheriff which arise from any acts or omissions of the insured, their employees, agents, servants, officials or administrators arising out of or related to the use of off-duty Ocean County Sheriff's officers"

7. Indemnification.

- A. The person or entity contracting for off-duty law enforcement services and the applicable insurer shall indemnify, defend and hold harmless the County of Ocean and Ocean County Sheriff, their employees, agents, servants, officials and administrators from and against any and all claims, or actions at law, whether for personal injury, property damage or liability including any costs of defense incurred by the County of Ocean and/or Ocean County Sheriff which arise from any acts or omissions of the insured, their employees, agents, servants, officials or administrators arising out of or related to the use of off-duty Ocean County Sheriff's officers.
- B. This indemnification and hold harmless agreement shall apply in all instances, whether the County of Ocean and/or Ocean County Sheriff are plaintiffs, defendants, direct parties to the initial action or claim or are subsequently made parties to the action by third-party in-pleading or are made parties to a collateral action arising, in whole or in part, from any of the issues from the original cause of action or claim.

Mr. Scarantino reviewed the items listed on the attached Engineering Department agenda. There were no questions or comments, and all items will be listed on the agenda for the March 18, 2015 Board meeting.

Ms. Vasil reviewed the Clerk of the Board's agenda for the Board meeting of March 18, 2015. There were no questions or comments.

Director Bartlett stated that earlier in the year departments submitted budget requests to the CFO and County Administrator and were reviewed by the Freeholders with their departments. The Director noted that these were budget requests, and each

budget was discussed and reviewed with each of the departments and their Freeholder Liaisons prior to submission to see what items need to be done and what items can be delayed. Director Bartlett stated that once the budgets are submitted to Julie Tarrant, she puts the budget together within the perimeters the Board of Chosen Freeholder's set. The Director noted that the two most important items to consider are (1) maintaining the Triple A bond rating and (2) the core functions the County must maintain.

Director Bartlett stated that the 2015 budget as introduced is \$408.4 million which is a decrease of \$27 million over last year's budget of \$436 million. The Director noted that the reason for this is that the 2014 budget was inflated because of the receipt of Superstorm Sandy funds. The Director noted that this year the budget is down; however, Superstorm Sandy continues to play havoc with the budget, many projects are still in the FEMA review process. The Director stated that compounding the problem is the net reduction in the County property tax base which is still down from its 2009 levels. The base was \$110 billion suffering a 16 percent reduction in the taxable base. The Director noted that this year the County has turned the corner and the tax base is up slightly, \$1.6 billion, a small increase, stating that most of this slight increase is from new and redeveloped construction.

Director Bartlett stated that the County's tax rate will increase from last year's 34.1 to 35.1 this year, which is approximately a 1 cent increase. The Director noted that the 35.1 tax rate is still lower than 11 years ago in 2004; stating that if the County followed the cap 2 percent increase, the County would have had an increase of 50 percent more than it did. Director Bartlett stated that this County raises money only for what our obligations are, what we are obligated to spend. Director Bartlett advised that in this 2015 budget, the County has budgeted a \$22 million repayment for FEMA emergency funding. This is the third year of the five year repayment and the County is on schedule. The Director stated that this County has the largest road system in the State and this winter was difficult with freezing and thawing which opens up pot holes. The 2015 budget included a total of \$13 million of County funds for the Road Department for road reconstruction, truck and repairs. The County has been running with equipment that is aging and replacements need to be made. Director Bartlett stated that the amount allotted for the Board of Social Services is \$24 million for people in need and the County will do what it can for these programs. The meals on wheels program will be increased by 1/4 million. The Director noted that the County received an increase of \$3 million from the State for health benefit plans and patients in State mental institutions so the budget includes this additional \$3 million.

The Director noted that the total amount budgeted for Salaries and Wages has increased by less than 1/2 of 1 percent. It is not employees that are driving the costs; when the County had a vacancy, it is not automatically filled, the position must be essential and vital to County operations. Director Bartlett stated that one of the

reasons for the increase is due to the Jail, it came online at a difficult time; and noted that through the attrition of other County departments, the County has been able to bring the jail to a fully staffed facility. With less County staff, the work doesn't get done as quickly; but the County is getting things done.

Director Bartlett discussed the County's surplus noting that the Freeholders have been very mindful of the surplus; rating agencies look closely at the amount of surplus. The Director stated that in 2014, there was \$35.6 million in surplus and the County used \$16 million to support the budget which left \$19.6 million in surplus. Director Bartlett advised that during 2014, the County regenerated more than that amount, \$16.8 million and began this year with \$36.4 million in surplus. The Director stated that the County is increasing this by \$800,000. The Director stressed that the surplus is there and available if the County has to use it. The County is determined to maintain the surplus so that it can maintain its Triple A bond rating which allows the County to borrow money at the lowest rate possible. Director Bartlett noted that very few counties have this rating; and stated that the State of New Jersey only has an A+ rating. Director Bartlett stated that the 2015 budget will demonstrate again to the rating agencies that the County will stay where it is. The Director stated that this is a general overview of the high points of the 2015 budget and asked the other Freeholders for comments.

Freeholder Lacey thanked the Director for his presentation of the budget as always. The Freeholder stated that County roads are probably one of the largest expenses in the budget, noting that roads cost money. This has been a very tough winter on the County's roads, and unfortunately this costs money. The Freeholder thanked County staff for doing a great job as usual.

Freeholder Little stated that since the recession and Superstorm Sandy, Ocean County has experienced a 16 percent reduction in the ratable base but to be able to keep this budget in line with that ratable base is a very positive accomplishment along with the conservative efforts of this Board to maintain services for the Board of Social Services (BOSS). Freeholder Little stated that this year this Board is funding the BOSS \$24.1 million, an increase of \$849,000 which is a 3.7 percent increase through a formula the State established. The Freeholder noted that all of our departments have lost employees and many of them are still down employees. Freeholder Little advised that when an individual is placed in a State health institution, the County is responsible to pay for their care. This cost is up to \$3 million to pay for these patients. Freeholder Little also noted that the County will fund the VoTech the same as last year to make sure our young people can receive training and Ocean County College funding will be \$14.7 million. Freeholder Little thanked the Director for his work on the budget and the department heads for staying within the perimeters this Board proposed.

Freeholder Little stated that the County has negotiated with 21 collective bargaining units and the County has been successful in many of the settlements with approximately a 1.5 percent increase in salary and wages. The Freeholder noted that inflation is running high and the County has received reasonable cooperation from people who work for Ocean County, doing more with less.

Administrator Block stated that the budget is the framework for each department to work within. The Administrator advised that the County has excellent department heads and supervisors that work at it 365 days a year and continue to come up with ideas for funding through grants and other sources.

There were no additional comments.

Ms. Vasil read the resolution to move to closed session.

On a motion by Freeholder Little, seconded by Freeholder Lacey, the meeting moved to Closed Session at 4:50 PM for personnel discussion, appointments, reappointments, property acquisition and possible litigation. The motion was unanimously carried.

Freeholder Director John C. Bartlett opened the meeting at 4:00 PM and read the Statement of Compliance with the Open Public Meetings Act. The Clerk of the Board called the roll.

Freeholder Lacey reviewed with the Board members the 2015 Household Hazardous Waste (HHW) Program. The program will run from April through October. Residents can bring household waste, pool chemicals, and paint. The initial three locations are: Lakewood, April 17; Berkeley Township, May 30; and Stafford Township on June 6, additional locations will be announced at a later time. The Freeholder stated that residents can go to any of the sites, but preregistration is required. Clean Venture is the vendor and the cost is \$.38 a pound. Freeholder Lacey stated that last year the County collected 284,000 pounds of hazardous waste. The Freeholder stated that he encourages residents to buy only what they need to use. Ernest Kuhlwein, Director of Solid Waste Management was in attendance and advised that residents must be hearing the message to buy only what you need; the pounds

of hazardous materials collected has gone down over the years. Freeholder Lacey stated that it is all about educating the public.

Freeholder Vicari stated that the Tourism Department was been changed to the Department of Tourism and Economic Development. Tourism in Ocean County is tracked by the State of New Jersey and is a \$4.4 billion industry per year. The Freeholder noted that tourism in Ocean County is family oriented. Freeholder Vicari introduced Dana Lancellotti to provide an overview of the grant program, noting that these are matching grants with nonprofit organizations. Ms. Lancellotti stated that the County received 56 submissions and 56 grants will be awarded with new groups submitting applications this year. The awards range from \$500 to \$2,000. Freeholder Vicari stated that before the grant program began a workshop was held to discuss the criteria to assist grant applicants in filing their submissions. Ms. Tarrant advised that the money is in the temporary budget for this program.

Ms. Vasil reviewed the Clerk of the Board's agenda for the Board meeting of April 1, 2015. There were no questions or comments.

Mr. Scarantino reviewed the items listed on the attached Engineering Department agenda. Mr. Scarantino noted that there is an ordinance on the agenda which includes State aid which is being held at this time by the State, however, the County needs to put its ordinance in place. Freeholder Lacey stated that the NJ Transportation Trust Fund has essentially just enough money to fund the current debt service. The Freeholder stated that he felt the County would not be receiving money from the NJTPA. Freeholder Lacey stated State Legislators have some tough choices that need to be made; but roads must be fixed especially after the winter we have experienced. There were no questions or other comments, and all items will be listed on the agenda for the April 1, 2015 Board meeting.

Director Bartlett asked the Board members for comments.

Freeholder Vicari stated that the depressed areas of Ocean County such as Lavallette and Ortley Beach (due to Superstorm Sandy) are having difficulties with banking. Many local businesses do not permit debit cards for small purchases due to the costs associated from banks to the local business which is hurting business. Freeholder Kelly noted that the owner loses money when debit / credit cards are used for each transaction. The owner pays the cost from the credit card company for use of the card for small sales; however, the owners are much better served by using charge cards, if they don't, they lose a lot of business. Freeholder Vicari stated that this is hurting small businesses, they are not making it. The Freeholder noted that this past winter was a terrible one as well. Director Bartlett stated that the County recognized problems with the Route 35 construction and noted that the project should have started as soon as possible after the storm. The Director stated that it takes time to build the entire roadway, but there is no simple solution. Freeholder Kelly noted that if we keep waiting to get the roadway done because of summer tourism or special events, when do we get it done?

Freeholder Kelly reported that the Ocean County Training Center has added four classrooms and the County anticipates getting the CO's for the building in the coming weeks. The Freeholder noted that the main reason is the use for the VoTech and scheduling for fire companies and EMS training. Classroom space was given to the VoTech and this presented a problem, therefore the reason for the new classrooms. The Freeholder stated that the County supports the program for the VoTech, it is a very good program and it has grown substantially. The project is near completion.

There were no additional comments.

Ms. Vasil read the resolution to move to closed session.
